### Background

 Pursuant to paragraph 4 of Part 3 Section D, the Directors of Wiltshire Council are is empowered to take all necessary decisions in cases of emergency. This decision is being taken by Andy Brown, Corporate Director of Resources, using these powers in circumstances where the Director concerned believes that there is a risk of damage to property, a threat to the health or wellbeing of an individual and/or that the interests of the Council may be compromised if this decision is not otherwise taken.

#### **Reason for decision**

- 2. This decision would in other circumstances be taken by Cabinet. However, in circumstances where the Cabinet is unable to meet to expedite its functions in a timely manner during the COVID-19 pandemic, this decision is being taken in accordance with the power referred to in paragraph 1 above in consultation with the Leader and other members of the Corporate Leadership Team. This decision will be reported to the next meeting of the Cabinet.
- 3. The Council has received £11.5m of funding from Government for use to help reduce the spread of coronavirus and support local public health.

# CLT 1 APRIL REPORT – FOR DHSC GRANT RETURN:

At CLT on 7 January it was approved to allocate out the £5m funding received for COMF against the activities listed in the table below. However given the uncertainty around cost, particularly for recharging staff time, and the lack of clarity on rollover/spend by end of financial year these allocations were uplifted to match the total funding received and indicate to DHSC that the fund was committed to be spent.

Since then it has been confirmed that the COMF funding can be rolled forward into 2021/22 as well as further funding being received. Total funding received now stands at £11.536m.

A return to DHSC on the allocation of this funding needs to be made by Easter Monday to enable the Council to be included in the allocations of the £400m national funding for 2021/22.

Proposals were asked from Directors for considerations on top of the approvals given above for consideration against the £1.7m funding allocation received for January. In addition, a task to capture activity from services that have been undertaken by staff supporting activities and cost linked to the already approved activities and funding is underway.

The table in appendix A lists the £4.5m of director proposals received and, following consideration by the Councils DPH, has recommendations for CLT on the activities to approve in this 2<sup>nd</sup> round.

There is concern around the uncertainty of the funding from Government in the £400m as well as the level of demand and requirements/conditions that maybe placed on the Council, in particular Public Health, in 2021/22. Although the COMF will be used to fund Public Health 'costs' in 2020/21 & lead to an underspend which will be transferred to the Public Health Grant reserve, this will be reported to Govt and should be used to fund Public Health activity as per the grant conditions/requirements.

Therefore, in addition to these proposals, it is proposed that £2.750m is set aside in the COMF to deal with specific containment activity / Public Health demands, to be determined by CLT during 2021/22.

A proposal to allocate up to £500K for increased costs in relation to the elections is also asked to be considered and approved.

If CLT were to approve Appendix A, plus the additional proposals set out above, there would still remain a balance of just under £2.5m which we would classify back to DHSC as contingency in our plans.
