

Moving traffic enforcement survey

Wiltshire Council is planning apply to the Secretary of State for the power to enforce moving traffic offences, and we want to hear your views on the first six junctions that could have cameras installed on them.

Moving traffic offences, which are currently only enforceable by the police in Wiltshire, include driving offences such as going the wrong way down a one-way street; driving through a No Entry sign; or turning left or right where it is not permitted.

We have initially identified six sites where moving traffic offences regularly take place and would like your views on the suitability of installing cameras at these sites to catch offenders. In the future, we will also be installing cameras at other junctions, and if you wish you can share your suggestions for suitable sites at the end of the survey. The survey is open from Wednesday 17 May until 23:59 on Wednesday 28 June.
