- 1. THE COUNTY OF WILTSHIRE (ROYAL WOOTTON BASSETT) (PROHIBITION AND RESTRICTION OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING) CONSOLIDATION ORDER 2016 (AMENDMENT NO.4) ORDER 2023
 - 2. THE COUNTY OF WILTSHIRE (VARIOUS ROADS, ROYAL WOOTTON BASSETT) (20MPH SPEED LIMIT ZONE) ORDER 2023

NOTICE IS HEREBY GIVEN THAT Wiltshire Council proposes to make the above Orders under the Road Traffic Regulation Act 1984 and Order 1 under the Traffic Management Act 2004 the effect of which is as follows:

Order 1

To amend the following restrictions in the **Royal Wootton Bassett** Consolidation Order 2016 by revoking Map Schedule Nos. BP69 and BQ69 dated 11th March 2016 and replacing them by the insertion of revised Map Schedule Nos. BP69 and BQ69 the effect of which will be to introduce **No Waiting at any time** on the following lengths of roads:

Beaufort Avenue – all sides – from a point 28 metres north east of its junction with Cloatley Crescent for a distance of 48 metres covering both turning heads

Buttermilk Crescent – all sides – from a point 23 metres north east of its junction with Cloatley Crescent for a distance of 25 metres covering the turning head

Cloatley Crescent (eastern spur) – all sides – from a point 21 metres north of its junction with Cloatley Crescent for a distance of 50 metres covering both turning heads

Cloatley Crescent (western spur) – all sides – from a point 28 metres north of its junction with Cloatley Crescent for a distance of 14 metres covering the turning head

Daisy Brook – all sides – from a point 16 metres east of the access to Brewery Place for a distance of 31 metres covering the turning head

Daisy Brook – all sides – from a point 63 metres east of the access to Brewery Place for a distance of 28 metres covering the turning head

Daisy Brook – north east and south east side – from a point 7 metres north west of its junction with Buttermilk Crescent for a distance of 17 metres in a south east and then south westerly direction

Hart Close – all sides – from a point 87 metres south of its junction with Cloatley Crescent for a distance of 23 metres covering the eastern turning head

Hart Close – west and north side – from a point 72 metres south of its junction with Cloatley Crescent for a distance of 24 metres in a south then westerly direction

Hart Close – all sides – form a point 2 metres west of the boundary of property known as 12 Station Road for a distance of 112 metres covering the western turning head

Red Lodge Close – all sides – from a point 25 metres south west of its junction with Cloatley Crescent for a distance of 32 metres covering the turning head

Order 2

To introduce a **20mph speed limit** in **Royal Wootton Bassett** on the following lengths of roads:

Beaufort Avenue – the complete length
Buttermilk Crescent – the complete length
Churn Way – the complete length
Cloatley Crescent – the complete length
Daisy Brook – the complete length

Dior Drive – the complete length **Hart Close** – the complete length **Red Lodge Close** – the complete length
