certainly an area where there is a high level of children accessing the village play area. Surely it makes more sense to include this area of Nettleton road as well and not start it half way down the road? Why has this not been considered as part of the amendment?

- The only people accessing the areas of Church Rise, Church Hill, The Meads and Burton Farm Close are local residents and they would not be travelling above 20mph in any case since they are residents, there is probably little chance of going 20mph in any case and are already aware of the safety issues?? So the only effective change is about 100yds of Nettleton road.

2. In relation to Order 2

- Whilst I understand there is an additional change from 40mph to 30mph in the northern part of B4039 which is of benefit, why is there no change from 30mph to 20mph in the actual village itself? This is the worst part of the B4039 and one where the speed of 30mph seems excessive in relation to the number of children and pedestrians on that stretch of road (certainly more than on the above order for Nettleton road.
- The speed of 30mph (which is often exceeded as will be evidenced by the Burton Speedwatch group details of which I am sure you will have access to) is too fast for a small village like Burton. This is compounded especially on days when there are events at Castle Coombe circuit, where cars are routinely travelling more than 30mph, and often above 40mph, with little regards for residents.
- The speed watch group reported in January 2024 that 34 vehicles in 6 sessions exceeding 36mph and in February 2024 that 40 vehicles were above 36mph. Have these speeds and reports been considered in your thinking?

I appreciate that changes are slow to make and require consideration from all parties, but I would be grateful for your comments in relation to my above queries. I do not wish to slow down the proposals, but do suggest that you consider and think more broadly about the impact of your proposal and not the narrow limit proposed.

With regard to order 2, the speed limit assessment did not recommend any further reduction in speed from the existing 30mph speed limit. This assessment process takes into consideration average vehicle speeds, vehicle volumes and collision statistics when determining the appropriate level of speed limit.

Where there are concerns regarding pedestrian safety, engineering measures to mitigate these concerns should be investigated. A request for measures to address pedestrian safety concerns may be raised through the Local Highway and Footway Improvement Group process. More information of this process can be found here
