This will be an area board hosted health and wellbeing event, as one of the health and wellbeing groups engagement for the year. The overall aims are to facilitate discussion regarding dementia support, from a user and carer perspective, to refresh local insight as to what is needed to strengthen that support, and to see whether the area board can respond in anyway at all to what is requested. The event will also aim to raise the profile of existing groups, activities, initiatives currently supporting older and vulnerable adults, including those living with dementia. The event will be facilitated by health and wellbeing practitioners from the Celebrating Age Programme, and will include include a light buffet, and a chance to meet together in friendship and fun.

Project Summary:

Messums Studios is proposing to deliver a series of ceramics workshops which would offer the opportunity to young people to experience hands on clay and ceramics creative learning delivered by experts in the field of ceramic art. Messums Studios operates a year long regular programme of creative learning which is subject to tuition fees. We are acutely aware of the fact that creative education and material learning has been, over the past decade or longer, diminishing in mainstream education. We seek this funding to offer the following courses aimed at young people ages 13+ free of charge. The proposed activity would take place on the following dates 1 March (1/2 day workshop), 7 April (day workshop), Two part workshop 26 May (1/2 day) and 30 May (1/2 day). The individual days would cover the following topics; First workshop: 1 March (10.00- 13.00) - Running concurently with the Ceramics Symposium in the Messums West Gallery in Tisbury, Messums Studios would like to deliver 'Young Clay Symposium'. Targeting age group of 13+, this hands on creative course would explore the topics of the vessel and abstraction, and would give the young participants the opportunity to design their intended sculptural structures in 2D and execute their intention in clay. Second workshop: 7 April (10.00 - 14.30) RAKU day for young people. RAKU is a firing method derived from the ancient Japanese ceremonial ceramics firing process. Modern day RAKU offers the most immediate insight into the ceramic process. An outdoor firing method which involves fire, smoke, and steam; unlike any other glaze firing it offers the participant an immediate and exciting result. In this course young artists would learn to glaze and observe the firing process and participate in unveiling their resulting pottery. Third workshop: 26 May (10.00 - 13.00) and 30 May (10.00-13.00) (Two part workshop) Part one 26 May - Clay sculpting workshop - 'Modelling the wild figure'. Using specialist sculpting clay, the young participants would learn how to model the figure of a human or animal in clay. The young people will be encouraged to observe and translate into their clay figures a movement such as dance, running, or jumping. The work would be biscuit fired ready for the second workshop. Part Two 30 May Saggar firing - In this second part of our two day workshop, young participants would have the opportunity to experience a saggar firing in our outdoor RAKU kiln. Firing their wild figures using upcycled metal coffee containers as saggar cases, participants will learn about achieving low fired fascinating and unpredictible reduction effect surfaces. Messums Studios was formed under the wider umbrella of Messums.org, a dynamic and progressive arts organisation which operates across multiple venues in the UK and regularly collaborates with cultural organisations abroad. Messums Studios is the community-facing educational branch of Messums West, part of Messums.org. Messums Studios was established in Chilmark, Wiltshire in July 2021 to support life-long creative learning with an emphasis on the tuition of skills, material knowledge, and critical thinking. Through the way we teach, we seek to provide everyone with pathways to develop the means to express themselves and to communicate confidently using their own visual language. Messums Studios operates under the direction of Messums.org director and Studios founder, Johnny Messum, and works closely with all colleagues across all Messums.org venues. Messums Studios Education programme is led by artist, educator and visual arts advisor Mirka Golden-Hann.

Project Summary:

Leisure Credits is a social action initiative delivered by Seeds4Success, where young people aged 12+ carry out a range of volunteering jobs within the local community that are of benefit to the environment or others and in return young people earn credits for their work. Sessions run on alternate Saturdays throughout the year as well as on most Tuesdays and Thursdays during the school holidays. This project benefits the young participants, through developing a range of social and practical skills as well as the wider community, through young people helping with community events, improving the large network of rights of way or enhancing local play areas.

Background
