The Calne Partnership of churches provides a team of volunteers (including 3 schools workers) to man the bus so that it is a safe and interesting environment for the young people. We have support from the local police and sainsburys. Parents have commented that "It is a safe place for my children that they enjoy, making friends." We believe that anti social behaviour is reduced and the police like the bus to be in Calne saying "It is a good place to meet good adult role models". A lot of vunerable children use the facility, they develop peer to peer friendships which combats their fears of bullying. Vunerable young adults have also benefited as younger people have developed more care & respect for them instead of the usual mocking and ridiculing. They have asked about their health and have had conversations with them. Non users of the bus have commented that they feel safer when the bus is present.
