<p>The Task Group held its inaugural meeting on 24 September 2012. This meeting was held at short notice as Members wished to consider the documentation surrounding the public consultation prior to its publication on 1 October 2012.</p> <p>The Task Group examined in detail the eight documents provided and made a number of recommendations in respect of the documents which were noted by the officers present.</p> <p>It is proposed that the Council charges a flat rate of £70 per metre<sup>2</sup> for residential development. The Task Group is keen to investigate the impact of this figure on those who will be affected by its implementation. The Chair of the Task Group will meet with officers in the week beginning 5 November to identify potential witnesses for this exercise; these will represent a range of users including a large developer, an agent and an individual.</p> <p>Once the witnesses have been identified, a date will be set at which the Task Group will speak to each witness individually. It is anticipated that this exercise will be completed before the next meeting on 28 November.</p>
