It is also a key area in which the village can carry out fund raising activities in order to generate income to further support the community.

Wilton estate will grant a 10 year lease if this grant application is approved. The sorting out of the ground is just the start. A separate group of willing volunteers has also been setup to assist the parish council to enable this project to come to fruition. Community rounders and other sports take place during village fetes but inevitably stop short because of the unevenness of the ground. If the field is left to worsen and left unkempt and uncared for it will only continue to attract a few youths who use it during the summer months as a drinking and smoking hang out. We want it to be a place the whole community want to go to, not a place to be avoided and forgotten. It is the only community asset, apart from the pub and the church that the village has, having lost the school when it closed, and is a vital component in regenerating an optimis
