			an exciting learning environment; it is well resourced and children enjoy making the most of the								
			well organised spaces available, particularly outdoors. Most children join the nursery with skills								
			and knowledge which are below those expected for their age, particularly in communicating, language and literacy. They make an excellent start to their learning because of the well								
			established routines and calm approach by knowledgeable staff. By the time they join the								
			Reception class, they have established good skills as independent learners and have made up								
			ground." The significance of this comment is that it identifies the benefit of the Nursery to children from disadvantaged backgrounds who come in with skills and knowledge below general								
			age-related expectation s. It is such children who benefit most from a nursery place in a setting								
			led by a specialist qualified teacher. Since I became responsible for the Nursery in September								
			2009, with the School's support, I have invested considerable time and energy in developing my								
			specialist expertise in the EYFS and have been recognised as an Early Language Lead Practitioner as an outcome of the Every Child A Talker project. Additionally, Bath Spa University has awarded								
			me a Certificate of Participation in Professional Learning for completing the module Work-based								
			Action Enquiry – Wiltshire Advanced Early Years Practice. At the end of January, the								
			Government announced proposals to change the adult/child ratios in Early Years settings and to								
			raise the qualification requirements for the adults working in them. Anne Longfield, chief								
			executive of children's charity and nursery provider 4Children, said: "The welfare of the child must be our first concern t hroughout, but with highly qualified early-years teachers and a better								
			inspection regime, there is an opportunity to review current arrangements and provide simpler								
			information for parents and better incentives for providers to concentrate on what matters -								
			children." I believe that closing the Nursery would: • disregard the Government's proposals								
			noted above • disregard the achievements noted by Ofsted and the investment in raising standards even further • diminish the range of opportunity available to the children of the local								
			community.

39		1	The school is fortunate enough to have a team of teaching staff and TAs skilled and experienced			1					
			in the teaching of early years; it would be a shame to waste this - especially since much of their								
			training has been paid for through the school and local authority as 'in service' training. St								
			Dunstan's most recent Ofsted report states that 'They make a good start on their learning because of the good, and often outstanding, teaching they get in the nursery and Reception								
			classes.' Children in the nursery 'make an excellent start to their learning because of the well								
			established routines and calm approach by knowledgeable staff'. In addition, the closure of the								
			nursery would undoubtedly mean that some staff members within the existing Foundation Stage								
			team would end up working outside of the age-group in which they are most experienced.								
			Whilst the proposed closure suggests it is in part due to the fact that there are other Founda tion								
			Stage facilities within the locality, it is fair to say that none of them benefit from being led by an								
			experienced nursery teacher, including Sunbeams, who, it is proposed, will move into the St								
			Dunstan Nursery building. Ofsted attributed much of the success in the Foundation Stage to the								
			environment and resources: 'The Early Years Foundation Stage provides an exciting learning								
			environment; it is well resourced and children enjoy making the most of the well organised								
			spaces available, particularly outdoors.' Whilst Sunbeams would continue to enjoy the benefits								
			of the outdoor space, which comes with the existing Dunstan Nursery building, our own children								
			won't see these benefits, nor will they see the benefits of the extensive and expensive resources								
			from the closing nursery, as there are not the facilities to store them within the school building – at least, not making it practical to access on a regular basis. The nearest maintained nurseries, if								
			our nursery closes, are in Trowbridge and Salisbury, therefore making it logistically impossible for								
			nursery-aged children in Calne and the surrounding area to access a school nursery. With that in								
			mind, it is also true that the children within the St Dunstan nursery benefit from being with								
			other children of the same age, rather than being mixed with much younger children, who's								
			needs are very different, through attending such a pre-school. With the new government								
			initiative to fund places for 2 year olds, it would surely be beneficial to both the Dunstan Nursery								
			and Sunbeams Nursery for the latter to take the 2-year-olds, whilst the school maintain their								
			excellent standards in developing the curiosity and love of learning in 3-year-olds. Historically,								
			Sunbeams have not recommended the school nursery for 3-year-olds, so this would surely

			has been limited and also the fact that parents of prospective nursery children were turned away								
			for this academic year (heard directly and indirectly from the parents of these children), thus the								
			figure of '10' is not a true representation of the need for this facility. Parents have also shown								
			dismay at the fact that their young child/ren will not be able to attend St Dunstan Nursery in								
			future years, especially when older siblings have thrived as a result of joining our school								
			community at a young age. Prior to the current academic year, falling numbers may also be								
			attributed to the closure of the afternoon nursery session; many parents require the flexibility of								
			having morning and afternoon sessions available in order to arrange their childcare. That said,								
			numbers are certain to rise with the development of homes on Sandpit Lane and a generally i								
			ncreasing birthrate nationwide. Finally, I propose that overall falling numbers will not be helped								
			by the closure of our nursery; figures in recent years show that very few children enter their
