

## Connect2 Wiltshire Amesbury Taxibuzz consultation

### Summary of written responses

Willow House, Countess Road (residential care home for learning disabilities)	Taxibuzz is relied on by their residents (vulnerable people with mobility issues) for access to day centres and activities, travelling out at lunchtime and return c 1630; medical appointments at various times; connecting with buses to Salisbury at various times. Proposed timetable would not meet their needs - 0925 dep is too early to be used; 1155 would be OK for short stay in Amesbury but not for longer visits or returning from Salisbury;	revised proposal includes two additional round trips to Countess Road to provide more journey opportunities
Shrewton & Till Valley Link scheme coordinator	Glad service from Shrewton and Rollestone not being withdrawn as is the only public transport to Amesbury. Link scheme also arranges much transport to Amesbury but is finding it increasingly hard to find volunteers. Taxibuzz should be publicised more locally to make potential users aware.	noted. Assistance from local communities would be welcomed to publicise the service locally.
Cllr Ian West	Is an extremely important service to the rural communities. Has not been well advertised - leaflets available, but needs to be advertised to Parish Councils and in the Valley Community Newsletters	noted. Amesbury is their nearest town</p>	<p>not proposed to continue service as it is very poorly used and would incur extra cost to operate. Are regular alternative services to Salisbury from all the places served.</p>
Allington with Boscombe Parish Council	<p>Would like service retained, especially as main bus service also significantly reduced recently. Accepts poorly used at present, but although residents heard of service, do not have specific info on times, fares etc. Should be promoted locally in the village (locations suggested)</p>	<p>not proposed to continue service as it is very poorly used and would incur extra cost to operate.
