Investment Objective and Policy

The Charity Fixed Interest Fund aims to provide a total return (income and capital growth) similar to or above the FTSE Actuaries British Government All Stocks Index. Investment is concentrated mainly on a diversified portfolio of UK gilts and corporate stocks, although the Fund can invest more widely in convertible preference shares, sterling denominated bonds and overseas bonds.

Risk Considerations

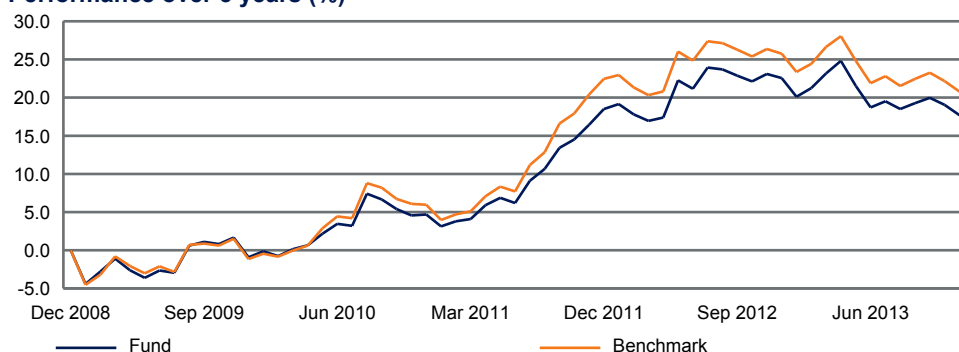
Funds that invest in a smaller number of stocks carry more risk than funds which spread their investments over a larger number of stocks. As a result of the annual management fee of the fund being charged to capital, the distributable income of the fund may be higher but there is the potential that performance or capital value may be eroded.
