## TRAFFIC CALMING - ABBERD WAY, CALNE

# **Purpose of Report**

1. To consider the points of objection received following the advertisement of the Traffic Regulation Order (TRO) associated with the proposed Traffic Calming in Abberd Way, Calne.

# Relevance to the Council's Business Plan

2. Outcome 3 - Everyone in Wiltshire lives in a high quality environment.

Outcome 5 - People in Wiltshire have healthy, active and high quality lives.

#### **Background**

- 3. Abberd Way has been highlighted as a location for improvement, based on a request from the Sandpit Road Section 106 Working Group. The group was set up to prioritise and spend Section 106 funding obtained from the Sandpit Road development in Calne. This scheme has been developed to slow traffic and improve safety for pedestrians crossing Abberd Way and also as a link in a wider cycle network for the town.
- 4. The TRO for the proposed 'No Waiting At Any Time' restrictions necessary for the traffic calming has recently been advertised. As a result, one letter of objection has been received, although this objection does not directly relate to the principle of the proposal.
