Risk Considerations

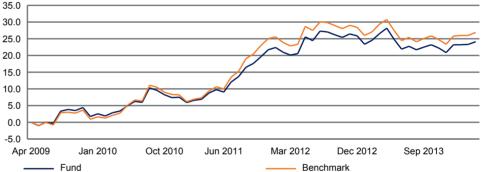

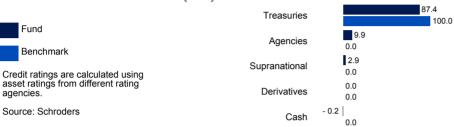
