

## **Wiltshire Council Statutory Notice for a Proposed Enlargement to Greentrees Primary School and the establishment of a Resource Base (RB) for 14 pupils with Statements of Special Educational Needs (SEN)**

Notice is given in accordance with section 19(1) of the Education and Inspections Act 2006 that Wiltshire Council intends to make prescribed alterations to Greentrees Primary School, Sycamore Drive, Bishopdown, Salisbury SP1 3GZ from 1 September 2015 (enlargement) and 1 September 2015 (establishment of Resource Base)

Wiltshire Council proposes to enlarge the premises of Greentrees Primary School by incrementally admitting an additional 26 pupils into the reception year from September 2015. This will be accommodated through phased building works to provide purpose built new accommodation on a new site and remodeling of existing accommodation.

The current capacity of the school is 238, and the proposed capacity will be 420. The current number of pupils registered at the school is 238. The current admission number for the school is 34 and the proposed admission number will be 60.

In September 2015, following the addition of new purpose built accommodation on a new site nearby; it is proposed to permanently establish a Resource Base (RB) for 14 stated pupils aged 4 to 11 (pupils will be admitted to the provision incrementally from 2015). It is intended that the school's RB will make provision for the following type(s) of special educational needs (SEN): autistic spectrum disorder.

The new purpose built facilities will cater for the needs of the existing school population and for the specialist needs of the proposed 14 RB pupils. The new facilities will be implemented by Wiltshire as part of the Capital Programme.

Admissions to the RB established at the school will be coordinated by the Local Authority, based on the provision stipulated in a pupil's Statement of SEN.

### **Explanatory notes**
