I suggest Councillors need to bring chairs & sit outside my house from 11pm to 3am to get proper structure of what exactly takes place. I have lived opposite that club since 1985. Broken sleep at wk ends is intolerable. Youth misbehaviour includes opening gates, ringing door bell etc. More than once I have had to call police who do not live on Station Hill. Councillors who do not live on Station Hill cannot possibly know the persecution suffered. Close at 11pm = my suggestion & NO Music
