S2	Devizes Area Tourism Partnership They were painted as a result of support of the Devizes Town Council and Devizes Area Board and were the final element to enable achieving the Coach Friendly Town Award from the Confederation of Passenger Transport. With the support of all related organisations, including Philip Whitehead, was achieved within a week of them being installed, making Devizes one of just 20 towns and cities. Many others have been trying for much longer, and I understand we broke records, especially as many had spent many thousands. We are in the process of the next annual Benchmarking study, but the results are not available yet. In the meantime I attach a collection of current quotations volunteered by representatives of key Devizes organisations, and 2 pages of images including the varied coaches now making use of Devizes, to the benefit of the local economy. None of us are near the bays on a regular basis, or with time or camera poised, to take potentially many more. The benefit should however start to reflect in toilet and coach parking revenue for Wiltshire Council? I could have obtained many more quotations, if for example approaching the key restaurants that have supported the project. I have had no negative reactions, it has been more how we can improve promotion to Coach Operators. The work to promote is by volunteers having no direct benefit from the outcome, and the minimised expenditure has been about £800, gleaned from different sources, Devizes Town Council, DCAP and volunteers. With a larger budget more could be achieved, and urgently, as coach operators are currently planning for 2015.
